Providing medical, therapeutic and/or somatic therapy for them, if necessary.

With its social, educational and cultural programmes, **Menedék – Hungarian Association for Migrants** has been supporting the social inclusion of migrants arriving to Hungary and immigrant Hungarian and foreign citizens leaving Hungary for more than two decades.

We support migrants arriving to Hungary with individual and group counselling, language training and social programmes to get to know and accept Hungarian culture and customs, to find jobs and housing and to be able to find their way in the long circuits of administration. Our professionals work in Budapest, Fót, Vámosszabadi, Győr, Kiskunhalas and Nyírbátor. It is important for us that the majority society become more accepting and openminded toward foreigners who arrive in Hungary since it is one of the essential conditions of their successful inclusion.

The objective of the project MENTORING FOR A JOB is to increase the chances of the employment of vulnerable, disadvantaged third-country nationals and to promote their sustainable presence on the labour market. By the method of social case work and by assessing individual needs, in the framework of Social counselling we aim at increasing employability.

Legal consultancy supports people during job search and in their sustainable presence on the labour market.

Occupational therapy is a group programme for clients who do not have work experiences. Our objective is to provide a community along the road leading to labour market integration.

According to a developed syllabus the Job seekers' club is an occupation which relate the following subjects: job interviews, job search techniques, intercultural meetings, trainings, document acceptance, characteristics of the labour market, business start-up, CV writing.

Mental health treatments with the involvement of psychologists and psychiatrists.

The Alternative group psychotherapy session provides opportunity for vulnerable people who do not speak the language very well and who find it difficult to express themselves to process the trauma they experienced. During the project Intercultural mediator training and internship we offer our authorised training twice. After the training, as part of our three-month programme for gaining labour market experiences, we provide intern positions to the participants.

Our programme Internship – business interns provides opportunities for third-country nationals to gain labour market experiences: for a three-month period, they perform internship duties for persons who have their own undertakings.

Hungarian language competence development is particularly essential for those clients whose specialization require targeted language competence.

The objective of the project INCLUSIVE KINDERGARTENS AND SCHOOLS is to support the inclusion of children and young people with migrant backgrounds.

#### Individual mentoring

Based on their individual needs (learning Hungarian as a foreign language, tutoring, development, etc.), voluntary mentors support foreign children and young people individually or in small groups.

Self-awareness developing occupations are group occupations organized for children and young people with migrant backgrounds which deal with their situations, identity issues with a guidance of an external expert (e.g. psychodrama teacher), on five occasions.

Leisure activities outside school: leisure activities for children with a migrant background or for Hungarian children (e.g. zoo, theatre, museum, picnic, excursion, etc.). Community development and sensitizing occupations are occupations in cooperating kindergartens and schools for migrant and Hungarian children about issues such as migration, cultural diversity and cooperation.

In cooperating kindergartens and schools, in Teachers' professional forums teachers share their experiences on issues concerning teaching and education of migrant children, and experts with specific competence in these subjects support their work.

#### Intercultural mediation

The communication between parents, families and teachers are supported by intercultural mediators.

Day care and sleepaway summer camps for children and young people with a migrant background.
